NEW JERSEY LEAGUE FOR NURSING PRIVACY POLICY

Thank you for visiting the New Jersey League for Nursing (NJLN) online services. The NJLN recognizes the public's concern about privacy on the Internet, NJLN's website, social media sites, and mobile applications. This privacy statement describes how information will be gathered about you from your use of these services and how it will be used by the NJLN. As a user, you should be aware that much information submitted to NJLN is public information under New Jersey State Laws. Under some circumstances, we may be required to disclose such information upon request in response to legal requirements.

The NJLN will make every effort to protect personal or business information you choose to provide electronically in the same way it protects personal and business information provided through other methods.

This privacy statement is provided for informational purposes only. It is not meant to be a contract of any type. NJLN may change its privacy statement at any time, without prior notice.

Information Collected Electronically

If you read or download information:

If you use the NJLN's website, social media sites, mobile applications, read pages, or download information; the NJLN may gather and store certain information about your visit automatically. (This is a routine function of websites.) We may store a "cookie" on your computer. (A cookie is a tiny element of data that a website sends to your browser. It is stored on your computer.) The information in this cookie is used only to identify your computer to our website, as we gather information to evaluate how visitors make use of the site so we may improve it. This information does not identify you personally. We automatically collect and store only the following information about your visit:

- The Internet domain and IP address for the computer you use when visiting our website (for example, "xcompany.com" if you use a private Internet access account, or "yourschool.edu" if you connect from a university's domain);
- The type of Web browser (e.g. Internet Explorer, Netscape) and computer operating system (e.g. Windows, Mac) used to access our site;
- Your screen resolution setting (e.g. 800 X 600 pixels, or 1024 X 768 pixels);
- Whether or not you've visited the NJLN's website before, and how long you stayed;
- The date and time you visited the site;
- The pages you visited; and
- If you linked to the NJLN's website from another site, the address of that site.

We use this information to help us make our site more useful to visitors -- to fix problems, and to learn about the number of visitors to our site and the types of technology visitors use. We do not track or record information about individuals, except as described below.

If you send email to a NJLN email address:

By sending us an electronic mail message, you may be sending personal information (i.e., your name, address, email address, etc.). We may store your name and address, and may share your email with various NJLN staff, to address your problem or concern or to answer your question. In addition, NJLN may be required to provide this information in response to a legal request or a court order.

Email is not necessarily secure and can be intercepted. NJLN has arrangements with some third parties for online payments of some NJLN fees. Always use those secure methods to pay any fees, fines or to make other NJLN payments online.

If you use an interactive application:

If you are filling out a form on the NJLN's website or using one of our online services, we may store a "cookie" on your computer. (A cookie is a tiny element of data that a website can send to your browser. It is stored on your computer.) The information in this cookie is used only to identify you to our online service or application, to make it easier for you to use this site.

Links to Non-NJLN (Third Party) Websites

The NJLN's website, social media sites and mobile applications contains links to information located on sites maintained by other public agencies and private organizations. Once you use a link to another agency, organization or company website, NJLN privacy standards no longer apply and you are subject to the privacy policy of that website.
